Commissioner Labrador said that he had never heard of any issues with the parking.

Commissioner Taylor-Moye said that she had been to the event in the past and it had always been very well run.

Mr. Burgos said that there had never been any issues with the event.

Ms. Feliciano greeted the Commissioners. She explained that they had decided to cancel the festival but would be holding the parade. Therefore, she was requesting that the Commissioners give the group permission to have the parade enter through the arches and turn to the left to exit

onto Main Street to avoid creating a traffic issue. This is their 30th year for doing this. Discussion followed about the details.

Commissioner Labrador said that it would be important to inform the participant of the parade about the change and to insure that those who park near the area all have parking passes.

Ms. Feliciano said that there had been some issues in the organization and that there would be a gala in September and a concert in October.

Commissioner Cotto said that it was very important to discuss this with Captain Cotto because of the change of the parade route. Ms. Feliciano said that the group was planning on meeting with the Police Department about this.

Ms. Feliciano said that she was amending her application, she needed to know if she needed to obtain all the other signatures. Commissioner Labrador said that they were not selling food or having vendors, so the most important signatures would be from the Police Department and Fire Departments. Ms. Feliciano said that she would be submitting the signatures to the Commission so everyone knows they have the permission.

Mr. Coombs said that they were looking to expand the Pride celebration in Wheeler Park. Bridgeport is the largest city in Connecticut and the fifth largest city in New England. They want to have a celebration for all the LGBT+ members and allies.

Commissioner Labrador explained that the Commission can grant permission for the usage of the park, but the parade would have to be approved by the Bridgeport Police. Mr. Coombs said that they have the support of the Bridgeport DSSD and were in the process of contacting the Police Department.

Ms. Urena confirmed that the park would be available.

Commissioner Labrador asked if the food trucks would be parked on the street. Ms. Kachmar and Mr. Coombs said that they were looking to close down the street from Wheeler Park, down Golden Hill to Lafayette Street. The Police Department is reviewing the application. The group has held the march for the last five or six years, but the new aspect is using Wheeler Park.

Discussion followed about the monitoring the sound level for the music since there are nearby residents and the location of the food trucks.

Commissioner Cotto said that particular street was very busy traffic area. Commissioner Labrador said that the Route 8 and 25 exit was right there. However, this street closure request was between the Police and the group.

Commissioner Wade asked who would benefit. Mr. Davidson said that the participants would benefit because it is family event.

Commissioner Labrador said that they would have to discuss this as a Board and would need a map of the area they would like to use, where the electrical generators would be and the sound levels would be.

Commissioner Cotto suggested that the proposal be put in writing and sent to the City Attorney's Office for review. Discussion followed about the details.

## **REPORTS**

### **1. Commissioner's Report**

Commissioner Labrador said that he had been driving around the city and seen how well the staff has been caring for the parks. He commented that there are people who want to add more parks, but that would mean they need more staff to maintain them. He said that he sees the staff out there and working on the improvements. The new signs have been installed and they provide the information for the visitors. The soft opening for the check points went fairly well.

## **2. Director's Report – Craig A. Nadrizny, Director of Public Facilities**

Mr. Nadrizny explained that while he would like to get the report to the Commissioners before the meeting, things change on a daily basis. Ms. Urena displayed a schedule of the upcoming events. She was asked if she could forward the spreadsheet to the Commissioners.

The Parks and Recreation Department report was displayed on screen and the various staff members gave overviews of the numerous projects including the LED signage, the Perry Memorial Arch, the Success Park Dog Park, and the City wide Tree Planting. Food trucks will be allowed in Seaside Park starting on May 27th and be allowed in designated locations on a first come/first serve basis. This inaugural program will continue through to October 15th.

Commissioner Hosier said that they had approved a total of 12 food trucks and this plan indicates 15 trucks. He asked if customers needed to have a sticker to get food from the trucks. He was told that some of the trucks were placed near public roadways for those who are not necessarily visiting the park.

Commissioner Labrador said that he did not mind the 15 food trucks in the park but had concerns about 15 generators running at the same time. He was told that the newer trucks have inverters and it was noted that the trucks are spaced throughout the park.

Commissioner Labrador asked about the requirements for the trucks coming into the park. He was told that they must have a Health Department permit and meet other requirements. Commissioner Labrador said that the check point staff would have to deal with food vendors that don't have all the necessary paperwork or permits. Discussion followed.

Commissioner Hosier asked that a copy of the food truck licensing agreement be sent to him. He asked if there would be designated food truck locations. He was told that they would have Lines and Signs come out to paint the parking spaces for the food trucks.

Commissioner Labrador asked to confirm that none of the trucks would be parked on the grass areas. Mr. Nadrizny said that they had placed the trucks where access to the concession stand would be a challenge.

**\*\* COMMISSIONER HOSIER MOVED TO APPROVE THE PROPOSED FOOD TRUCK PLAN.**

**\*\* COMMISSIONER GRISBY SECONDED.**

**\*\* THE MOTION PASSED UNANIMOUSLY.**

Ms. Conine then presented her report. She said that they had opened that week-end and it was a great week-end. The food truck program appears to be well thought out and she added that they had the check points up and running.

Life guard recertifications are underway along with camp registration. Mr. Nadrizny thanked the Park staff and Recreation staff for opening up early due to safety concerns.

Mr. Curry said that it was important to let people know that the concession stands RFP had been posted on Bid Sink.

Ms. Urena said that she would be emailing the basic information for the applications along with the other documentation that the Commissioners receive in PDF form to the staff so they have it in advance.

Mr. Nadrizny thanked everyone for their hard work, including the administrators.
