INTRODUCTION OF NEW PARKS BOARD COMMISSIONER, LEE GRISBY (R)

Commissioner Labrador then introduced Mr. Lee Grisby, the new Parks Board Commissioner.

APPROVE THE 2022 PARKS BOARD MEETING CALENDAR

- ** THE MOTION TO APPROVE THE 2022 PARKS BOARD MEETING CALENDAR AS PRESENTED PASSED UNANIMOUSLY.

PUBLIC SPEAKING FORUM:

There was no one who had signed up to address the Board.

NEW BUSINESS:

1. Maria I. Valle, Councilwoman137th District, submitting a proposal to establish a commemorative walkway in Wheeler Park (aka City Hall Park) as a 'Walk of Honor' to recognize individuals' achievements in the City of Bridgeport.

Council Member Valle greeted the Parks Commissioners and explained that there were individuals who wished to honor someone by adding memorial street names. However, this confuses some residents and visitors when they need assistance since the memorial names are not listed on the maps. She said she would like to have some type of walkway with the individual's names leading up to City Hall.

Commissioner Labrador thanked Council Member Valle for the idea. He said there were questions like who would pay for it and wondered if there were grants that would cover the cost.

Council Member Valle said that the family should come up with the funding for the memorial brick, similar to the Veteran's Walk. Discussion followed about the minimum number of bricks that would be needed to start the project. Council Member Valle said that she would check with

Mr. Boyer to find out how much a brick costs. This project is in the beginning stages, so the measurements still need to be determined.

Commissioner Labrador said that he would love to see this happen, but suggested that it be tabled until they determine how long the walkway would be and how much it would cost.

Commissioner Hosier said that he would like to see some information on who the individuals were and why they were being honored.

Commissioner Cotto asked for clarification on where the walkway would be. He stated for the record that it should be noted it would be at City Hall located on Lyon Terrace and the walkway would be between the parking lot and the building.

Commissioner Labrador asked Council Member Valle to come back to the Committee with additional information in the near future in order to move the project forward.

2. Maria Pereira, Councilwoman 138th District, submitting a proposal to establish a Dog Park located at Success Park on behalf of constituents residing in the JFK Precinct and the Success Park neighborhood.

Council Member Pereira greeted the Commission and said that her colleague Council Member Small was not able to attend the meeting. She said that there were three pocket parks in her district and only one, Nob Hill, had a dog park. Wherever there are condos and co-ops, there are strict leash laws for the common areas. She listed the number of units that were in the nearby condo developments.

Council Member Pereira said that that Success Village was the largest co-op in not only Bridgeport, but also the State of Connecticut. There are 900 units, with 100 units in Stratford and the remaining 800 in Bridgeport. The Village abuts Success Park. There are more apartments on Palisades Avenue.

Council Member Pereira then described an area of the park that was under-utilized and fenced off on three sides. Council Member Pereira said that Mr. Nadrizny viewed the area and indicated that they could fence off the area and install a gate.

Success Village is the second largest taxpayer in the City. A lot of work has been done in that area to improve the area, along with the installation of new sidewalks and some new Habitat for Humanity homes. Council Member Pereira went on to describe some of the improvement projects that had been done on the Park over the years. She then spoke about a ceremony that was being planned for the area because this was needed for the nearby units.

Commissioner Labrador asked who would be financial responsible for putting in benches. Council Member Pereira said that Mr. Nadrizny indicated that it would be a minimal amount and that his Department could handle the cost.

Ms. Rowe said that she was a staff member and had been at the staff walk of the proposed area. She confirmed that it would be a nominal cost. She said that she had a map of the area. Commissioner Labrador said that he would like to view the site with Council Member Pereira so they can move the project forward.

Commissioner Grisby said that he thought it was a great idea and had seen the many improvements to the park over the years. He said that he would like to visit the area also. Commissioner Labrador said that they should schedule a date. Council Member Pereira said that she would contact Ms. Urena about this.

Commissioner Hosier had some questions about the height of the fencing. Council Member Pereira said that she thought it was similar to Nob Hill. Discussion followed about the details.

Council Member Pereira thanked the Commissioners for their time.

3. Tyisha Toms, Associate City Attorney, Bridgeport, CT, requesting to move forward with the approval of the partially executed Occupancy Agreement of Isaam Kadi at 1062 Church Hill Road, Fairfield, CT; known as D. Fairchild Wheeler Golf Course.

Mr. Kadi and Atty. E. Skyers introduced themselves to the Commissioners. Atty. Skyers said that he would be speaking on behalf of Atty. Toms. He welcomed Commissioner Grisby to the Commission. He said that recently some issues had been brought to the City Attorney's attention and so he was requesting that the item be tabled until the details could be clarified.

Commissioner Labrador thanked Atty. Skyer for his attention to details.

- ** THE MOTION PASSED UNANIMOUSLY.
- 4. Office of Central Grants, Bridgeport, CT, in partnership with Department of Health and Social Services and Parks Dept, Bridgeport CT, requesting to provide an update on the Fitness Court project previously approved for Seaside Park and to see approval for a potential 2nd court at Beardsley Park.

Ms. DeJesus greeted the Commission and said that she was also with Ms. Ebony Jackson-Shaheed, the Health Department Director and a staff member from the Parks Department.

Commissioner Labrador said that there had been a proposal a few years earlier about the courts at Seaside Park. He asked why the previously approved project had not happened.

Ms. DeJesus then updated the Commission on the status of the 2018 project which involved fund raising. Fund raising is difficult to do and was further delayed by the pandemic. She explained they had sought out different funding sources for the project and are waiting on final notification from one of the funding sources. The original proposal had been for one site at Seaside Park, which was at the old skate park location.

Ms. DeJesus said that they expected notification from the second funding source by the end of the month. If it is confirmed, they can put the Seaside Fitness Court up sometime in June.

Commissioner Labrador said that they had not given other projects a deadline. He said that he would like some kind of timeline for the start date and completion date for the project. Ms. DeJesus said that she would develop a timeline based on what was currently happening. Discussion followed about the details including liability.

Commission Labrador said that if they can put up the first court on the former skate board site, the Commissioners would then consider the second court.

Commissioner Wade asked what would happen if the funding does not come through. Ms. DeJesus said that the Commission's permission was if the funding came through then the project moves forward. If there is no funding, then there is no project.

Ms. DeJesus said that the submitted request was for the Seaside court and an additional one at Beardsley. She asked for clarification on what might be approved. Commissioner Wade said that they needed to complete the first court and then get approval for the second one. Ms. DeJesus said that her concern was that the second court might be delayed. Commissioner Labrador said

that if there was a problem with the first court, the second one would be delayed. He added that he did not expect there to be a problem.

- 5. Charles M. Carroll, P.T. Barnum Foundation, Inc. Trustee, Bridgeport, CT, requesting the use of Kennedy Stadium to hold the Barnum Festival Champions on Parade Drum Corp Show on Saturday, June 25, 2022. In addition, requesting the use of Seaside Park on Saturday, June 25, 2022, for practice fields. Requesting the use of Seaside Park on Sunday, June 26th for the Barnum Festival and Barnum Festival Fireworks.

Mr. Carroll greeted the Commissioners. Commissioner Labrador said that he had seen the Barnum Festival and the Parade of Champions for years. He asked Mr. Carroll what part of Seaside Park they wanted to use for the practice. Mr. Carroll said that Lee has been assigning them to the same area of the park for years. Once of the practice areas is up by the Soldiers, Sailors and Marine Monument, which is all grass. The practice lasts about until about 2 in the afternoon on a Saturday.

Commissioner Labrador said that in the past, he had noticed that they sometimes had grills set up to feed the band members. He asked if the Parade administration had thought about some child putting their hands on the grill. Mr. Carroll said they always give the City an insurance policy that indemnify city from the Barnum Festival. They do insure the City and Mr. Carroll give Mr. Flatto, the Finance Director the insurance certificate before Mr. Flatto signs off on the permit.

6. Pascale Butcher, Trifitness, requesting to organize the Seaside Triathlon event on Sunday, June 12, 2022, at Seaside Park with a start time at 7:00 a.m. Looking to set up the day before Saturday, June 11, 2022.

Ms. Butcher greeted the Commissioners and said that they have been doing this event for over 10 years. They are done by 9 a.m. and out of the park by 10 a.m. Last year they were not able to set up the day before, but she would like to set up in advance in order to set the markers. Mr. Burgos said that the group was very organized and there were no issues in the past. Ms. Urena confirmed that the dates were already plugged into the calendar.

Commissioner Cotto said that the park will be open when the event takes place. Ms. Butcher said that they were aware if this. She said that at 7 a.m., there are not many people in the park and they never had a problem. This is why it is scheduled early in the season.

Commissioner Labrador asked if there would be someone at the park to let them in. Mr. Burgos said that they have always sent someone out to open the gates.

- 7. Deborah A. Caviness, Juneteenth of Fairfield County, requesting the use of the Seaside Park Bandshell on Saturday, June 11, 2022, with a set-up time of 8:00 a.m. and clean-up time of 6:00 p.m. for their annual Juneteenth Community Festival with approximately 4,500 people in attendance.

Ms. Caviness greeted the Commissioners and explained that she was using someone else's computer. She said that she would like to use the Bandshell for a Harambe festival and the bath house to set up for the 30th Annual Juneteenth Parade. Last year, they were able to have the parade at the Park and it went well. She said that they were working with Mr. Don Wilson because they know Mr. Wilson will be having a Juneteenth Tournament for his teams.

Commissioner Labrador said that there were cars parked on the grass by Diamond 6. He wanted to make sure that no cars were parked on the grass at the Park unless Mr. Burgos or his staff is aware of it and designated where those vehicles can be parked. It costs a great deal of money to get grass back in shape. Mr. Burgos said that he was not aware of any issues.

Commissioner Labrador asked Ms. Caviness if she could meet with Mr. Burgos to work out the details of the area that they are looking to use. Ms. Caviness said that she had met with Mr.

Burgos and the Police Department to confirm the route. She explained that they line up for the parade by the bath house.

Ms. Caviness invited all the Commissioners to join them at the event and noted that Juneteenth was now a Federal Holiday.

8. Lorraine Gibbons, John Torres, Bridgeport, CT, requesting the use of the Seaside Park Bandshell on Thursday, May 19, 2022, for a Mindfulness event for Bridgeport Public School Students from 10:00 a.m. to 2:00 p.m. and a set-up time of 7:30 a.m. and clean-up time of 3:30 p.m. with approximately 100 people in attendance.

Ms. Danielle Bernard, of the Bring Bridgeport Community and Ms. Nicole Santos, greeted the Commission. Ms. Bernard said that they would like to present a program for the students on mindfulness that would focus on yoga and coping mechanism to reduce stress. It will be by the bandshell because there will be either a DJ or stations there. The students will arrive by bus and break into groups to each move through the different stations to learn various coping techniques.

She said that there will be volunteers to provide safety and security. If the event turns out to be well attended, they may ask the police to provide security.

Commissioner Labrador said that he had worked for the BOE for 35 years and knew some of the things that could happen. He pointed out that it would be easy for someone to infiltrate the program. He said that he was supportive of the students empowering themselves. Safety is his largest concern.

Commissioner Labrador said that he imagined that Superintendent Testani would be aware that the students would be bussed there. He added that parental permission slips would be required for the event. Ms. Bernard said that her group was planning on working with the guidance counsellors and staff to insure those who need it the most can attend the event. They are working with a member of the BOE to insure that this will be permitted.

Commissioner Wade asked what age students would be allowed to attend. Ms. Bernard said that they were targeting high school students. Commissioner Wade said that unfortunately there were

11 and 12 year old children that were committing suicide. She suggested that they consider possibly allowing the younger students, the 7th and 8th graders, to participate.

Commissioner Labrador suggested that Ms. Bernard reach out to Mr. Testani and Lt. Grech to see if they can provide security personnel from the schools, like SRO's.

Commissioner Hosier said that he appreciated the outreach. Ms. Urena said that the date was available for the bandshell.

Mr. Burgos said that they had not had any issues in the past. Commissioner Labrador said that it would be important to stay in their designated area because the park will be open to the public and they also need to be able to move about freely.

Commissioner Labrador asked for more details about the types of food that will be offered. Mr. Wilson said that he was there at the park 7 days a week. He previously had a restaurant and is SAFE certified. This particular event will be basic table top foods, such as hot dogs, ready-made cold cut sandwiches, chips, and fruit. It will be another pair of eyes there to prevent graffiti on the walls. They will just be using the concession stand, not cooking there.

Commissioner Labrador said that he would like to hear from Atty. Skyer about the liabilities. Atty. Skyers said they don't usually give legal advice off the cuff and suggested that a complete proposal be forwarded to the City Attorney's Office for review. Discussion followed.
