OPENING CEREMONY / PLEDGE OF ALLEGIANCE

Commissioner Labrador greeted everyone and called the meeting to order at 5:10 p.m. He led those present in reciting the Pledge of Allegiance.

Ms. Urena called the roll. A quorum was present.

** THE MOTION TO APPROVE MINUTES OF THE FEBRUARY 14, 2023 REGULAR MEETING AS SUBMITTED PASSED UNANIMOUSLY.

OLD BUSINESS

Commissioner Labrador announced that there were two items that needed to be expedited on the agenda. Ms. Urena explained that the Freedom Ride presenter had a schedule conflict and requested to defer to the April Agenda. This was acceptable to all.

Commissioner Labrador said that Council Member Pereira had a City meeting at 6 p.m., so he would like to have her address the Board now about an item of old business.

- ** COMMISSIONER COTTO MOVED TO CONSIDER AGENDA ITEM 10 THE UPDATED ON THE STATUS ON THE DOG PARK PROJECT AT SUCCESS PARK AT THIS TIME.
- ** COMMISSIONER WADE SECONDED.
- ** THE MOTION PASSED UNANIMOUSLY.
- 10. Maria Pereira, Councilwoman 138th, Bridgeport, CT, requesting status on the dog park project at Success Park.

Council Member Pereira said that she respects the fact that the Parks Commission has the right to make every decision about the City Public Parks. She reminded them that she had started a request to install a dog park at Success Park. Council Member Pereira then reviewed the history of her application for the dog park. She said that the item has been approved at the August 2022 meeting and installation was planned for October.

She said that she had followed up with Mr. Nadrizny but the fencing had not been installed due to the work load. She said that she had sent a strongly worded email about this on February 13th and requested to be placed on the March agenda. The first P.O for the project was issued the day after she sent the email.

Council Member Pereira said that she was informed that she would not be allowed to speak, but she does not live in Russia, China or North Korea. She said she lives in a democracy where people are allowed to speak to the School Board, the City Council or the State legislature on a first come/first serve basis.

Council Member Pereira said that she had to contact Deputy Chief of Staff, Tom Gaudett, and also Commissioner Labrador about this. When she was finally added to the agenda, she was place at the bottom of the agenda. She said that she felt that there was some type of Fascist or retaliatory behavior going on and this is not acceptable. Anyone, regardless of whether they are a Council Member or a homeless individual, should be given the right to address the Board.

Council Member Pereira asked how they could move this project forward. She said that Mr. Nadrizny had contacted her and said that the park will be installed by the end of April after the fencing is installed.

Council Member Pereira said that she was not asking for anything additional, but wanted to share with the Board what has been happening. This is not new business. She said that she knew they could not respond to her if she was place on the Public Comment list. She felt that there were a lot of shenanigans going on and that this was inappropriate.

Commissioner Labrador said that they did not place her in Public Comment because the Commissioners would not be able to reply to Council Member Pereira's comments. He went on to say that Council Member Pereira had spoken with the staff and a timeline for the project had been determined.

Commissioner Labrador said for future reference, the Board should not announce when a project should be completed because there are too many variables such as availability of materials and delivery schedules. While they can ask the staff about the status of a project, it is not their job to determine when a project should be completed. Discussion followed.

Council Member Pereira thanked the Commissioners for their time.

She noted that there was an increase in the number of Hispanic resident in the City during the recent years. The goal is to give the Hispanic community members a hand up rather than a hand out. She said that at the pantry, they have a large number of undocumented Hispanic people asked about various resources such as learning English, their citizenship, getting a GED or finding employment. This event will help empower the community.

Commissioner Taylor-Moye asked if a list of vendors was available. Ms. Rivera said that she had one firm commitment and the others were waiting on approval. Ms. Rivera said that the groups were actually service providers.

Mr. Burgos asked if they had a site plan laid out. Ms. Rivera said that she wanted the four Spanish churches located at the four corners and then would space the service providers out between them. He noted that they would need garbage cans and a site plan if there are tents. Discussion followed about the details including food, parking and bathrooms. The dates are available.

Dr. Valbrun greeted the Commissioners and then gave a brief overview of the event, which is to raise funds for a scholarship. He explained that Rev. Lord was the previous president of the

NAACP who has died. To honor his legacy, they are creating this scholarship fund. Rev. Lord had managed to raise over \$500,000 for students to go to college. He outlined the route the event would take and indicated that it was on the diagram.

Discussion followed about the fact that this was set up on Labor Day and they may have to close some streets. Commissioner Labrador pointed out that they can give permission to use the park, but not the streets. Concerns were expressed about the I-95 underpass.

Dr. Valbrun was asked if they had done this before. He explained that the NAACP had done this elsewhere, but not in Bridgeport.

Commissioner Labrador said that they would need a site plan at Baldwin Plaza and McLevy Green to review. Dr. Valbrun said that Baldwin Plaza will be just registration table. At Seaside Park, the runners will be turning around and heading back. McLevy Green will have a health fair. Dr Valbrun will meet with Captain Cotto about the route and other details.

Ms. Santa greeted the Commissioners and said she had great news. The safety fence was scheduled for today, but due to the weather, it was delayed. The first construction meeting will be held on Thursday the 16th at the site. They need a point person from the City for the project. Mr. Nadrizny said that Mr. Burgos would be the point person for the project.

Ms. Santa said that the project will take about five weeks and she reviewed the details of the installation. There will be underground irrigation.

Ms. Santa said that they had changed their plan and there was no need to discuss the location of a tree. They are hoping for a ceremony at the end of April. They have been working on this plan since 2017. She thanked the Commissioners, and generous donors: ETF, the Santa Energy Environmental Fund and O&G Industries.

Once this portion is completed, they would like to have benches and a few other items installed.

REPORTS

1. Commissioner's Report

Commissioner Labrador thanked Captain Cotto and to Chief Porter for having a representative present at the meeting. He suggested that Captain Cotto check in with Ms. Conine during the summer regarding the life guards and the summer programs.

Ms. Conine said that they were working on getting all the checkpoints organized.

Captain Cotto said that he would be the liaison for the Park Commission and was looking forward to working with everyone. He said that the important focus is public safety. Captain Cotto said that he had coordinated the events for the last seven years.

2. Director's Report-Craig A. Nadrizny, Director of Public Facilities

Mr. Nadrizny said that they have appointed a new Deputy Director, Aaron Curry, to oversee parks and he was present. Mr. Curry greeted the Commissioners and said they were doing an amazing job.

Mr. Nadrizny said that the Director's Report had been sent out and contained the list of on-going projects.

In reference to Council Member Pereira's comments, he reminded everyone that the Department has a budget that they have to maintain. There was only so much funding allotted for fencing and they needed to insure that there were funds available. There is a P.O. in place and the Department is waiting on the vendor to provide a schedule for the dog park. The vendor has

stated that they will be starting in mid-April and if there are delays, Mr. Nadrizny will be emailing the Council Member.

Commissioner Labrador asked for an update on the basketball program, which Ms. Haye provided for him. He also asked about the St. Patrick's Day luncheon at the Senior Center. Ms. Conine said that it was this Friday and everything was moving forward well.

Mr. Nadrizny said that there was an issue with people driving on the grass at Nolan Street Park. There is a P.O. in place for bollards to prevent this.

Mr. Nadrizny reiterated that they wanted to make sure they had enough money in the General Fund for the fencing at Success Park after the winter was over. He said that it was important for the Commissioners not set start dates for projects.

Commissioner Labrador agreed and said that there were too many variables that have to be considered. Commissioner Labrador welcomed Mr. Curry. He said that he will be working on overseeing the projects. Mr. Nadrizny said that if the Commissioners have suggestions or improving the parks, they should let him know and he will present it to the Council for the budget.

Mr. Lee Nastu said that even with the snow that fell during the day, the new sport season has started. They will be working on the dirt fields for the upcoming games.
