The meeting was called to order at 6:01 p.m.

## Item #3 Reports:

**a.** *Chief*: Acting Chief Rebeca Garcia presented the following to the board: The department continues to work with the Task Force regarding strategic enforcement focusing on hotspots. A/Chief Garcia is committed to reestablishing a relationship with the community and is working closely with Project Longevity. A/Chief indicated she has walked in many communities including PTB and the east end and will continue this practice of meeting with community members throughout the City. A new academy class of 16 police recruits started on September 14, 2020. The department is starting a recruitment program. The results from the recent detective exam has been published. A/Chief Garcia continues to work closely with the health department. Commissioner Roach commented on the great job A-Shift personnel did with an event that involved a large crowd in the downtown area this past weekend. A/Chief Garcia reports the department has started a focus group with officers. A/Chief Garcia reports that she would like to have an event with the BOPC and department members to recognize the good work of police officers. Commissioner Lyons asked A/Chief Garcia if enforcement of quality of life issues will continue in the North End and the issues surrounding SHU. A/Chief Garcia stated that enforcement will continue in this area and she will monitor this situation very closely with patrol command staff and SHU public safety director Gary McNamara. A/Chief Garcia also indicated the re-instatement of the Telephone Response Unit (TRU). Commissioner Farrow asked A/Chief Garcia what is being done to deal with the issue of Perez and can community members attend future CompStat meetings. This request was presented to the police commissioner by a community member several months ago.

A/Chief Garcia responded that she is working with the community to build bridges and emphasized the work of Community Services, Project Longevity and re-establishing work with Child Guidance in providing information to the community. The entire BOPC congratulated A/Chief Garcia on her recent appointment to Chief of Police.
