Commissioner Labrador said that a letter had been received from Callie Delgado thanking the Commission for their assistance with the East Side Day.

### **NEW BUSINESS**

1. Howard Saffan, Hartford Healthcare Amphitheater, Bridgeport, CT, providing an update on the diagram layout for the Sound on Sound Festival at Seaside Park for Saturday, September 30, 2023 and Sunday, October 1, 2023.

Mr. Saffan greeted the Commissioners and said that there had been a review of the Sound on Sound Festival and Live Nation had recommended that they move the site to between the soccer fields and the bath houses. The baseball fields have flooding issues if there was heavy rain. There were also some concerns about sanitation. The apartment building on Atlantic Street will not be bothered by the sound and the Police have said that the traffic issues would be greatly improved. The baseball lighting would no longer be a problem. He displayed an updated drawing and noted that the beach would remain open during the festival. The park will become even more accessible to the public during the festival and there will be a Ferris wheel. Discussion followed about the details.

Council Member McCarthy said that he was the liaison for the Parks Commission and asked for clarification about the accessibility of Soundview during the festival. Commissioner Labrador said that there would be security along the backstage area that would prevent the public from accessing the backstage area. Mr. Saffan explained that everything was subject to Homeland Security and the Bridgeport Police approval.

Commissioner Hosier asked about the details about the Ferris Wheel. Mr. Saffan said that the vendor operates the Ferris Wheel all over Fairfield County and the ride will be placed on an asphalt area. The area will be secured.

Commissioner Hosier had concerns about the Port-a-potties that were used last year. Mr. Saffan explained that they will have flushable toilets at the event to prevent the same problem from occurring.

Commissioner Cotto asked if the applicant had checked with the Police Department and the Health Department. Mr. Saffan said that there had been several meetings with Captain Grech and Lt. Simpson and the Health Department is working with them on this. Another meeting will be held on August 21st or 22nd with everyone.

# 2. Anthony Paoletto, City of Bridgeport, Office of the Mayor, requesting to put up a library box at Old Mill Green Park.

Commissioner Labrador asked Mr. Paoletto to give an overview of the project. Mr. Paoletto said that these were library boxes places at different locations in the City where residents could come and leave books or take one. McLevy Green has one of these small "Little Library" boxes. They would like to partner with Colors of the World and place one at Old Mill Green. Current the organization takes books that the schools are getting rid of and place them in the boxes for residents. McLevy Green is the only box on City property.

Commissioner Labrador asked what would happen if someone put inappropriate material in the box. Mr. Paoletto said that the volunteers have removed inappropriate material in the past.

Commissioner Cotto asked who would be maintaining the boxes. Mr. Paoletto said that Colors of the World would be responsible.

Commissioner Hosier asked how many times a month the volunteers visit the boxes. Mr. Paoletto said they try to go out once a week but will visit the boxes twice a month.

Discussion followed about the placement details. Mr. Paoletto said that they had considered putting it near where the annual tree lighting is held. Commissioner Labrador asked who would be responsible if someone was hit by a car while going to get a book.

Mr. Nadrizny said that it was about location. He suggested that the box be placed on one of the side roads rather than Boston Avenue. He suggested that the area by the Marin School splash pad and the parking lot might be a safe location.

Mr. Blagys, the chair of the Black Rock History Committee greeted the Commission and gave a brief overview of the Black Rock Community Council. The Council is involved with the preservation of the lighthouse. He said that this year was the 200th anniversary of the Lighthouse and this would be part of the celebration of that anniversary. He said that they had a firework display in 2019 and the Fire Department will need to be on site. The only people who will be on site will be the Fireworks Display staff, the Fire Department and the Police Department.

A lengthy discussion followed about the June 2019 permission letter. Commissioner Labrador said that the Parks Board had never approved that display. It was determined that Mr. John Ricci had signed the letter of permission for that display.

Commissioner Labador asked Mr. Burgos about how much usage that area of the park has during September. Mr. Blagys said that the Firework company only needs a small area of the park blocked off. The discussion followed about the safety during set up and display. Mr. Nadrizny said that the Fire Department and Police would have to approve the display. He added that the set up would be in the overflow parking lot that isn't used very much and Mr. Nadrizny felt that it would be fine. It is quite a distance from the street.

Commissioner Labrador said that they were approving the date and location. The Fire Department and Police will determine exactly where the display launching site should be. Mr. Nadrizny said that the Police will be on site and will lock the gates afterward. Mr. Blagys said that all the viewers would be watching from across the Harbor.

Sgt. Wiltsie greeted the Commission and said last year's event was a success and they would like to do it again. Mr. Burgos confirmed that the event had run smoothly with no problems. Sgt. Wiltsie said Mr. Saffan had opened the Amphitheater for the event and the participants enjoyed the event.

Mr. Dowd greeted the Commissioners and said that Mr. Zillow, a colleague, was present also. He said that the varsity and club games are played at Veteran's Park. An electronic scoreboard with a generator was installed a few years ago. Using the generator works, but is not ideal. There are issues when games go into overtime and the generator has to be refueled. There are also new rules for NCAA college baseball. They are now requirements for pitch clocks beginning in January 2024. The University is requesting permission to install permanent power and to install pitch clocks on the field. The two clocks allow the umpires to be able to see the clocks. The plan is to trench around the field.

Commissioner Labrador asked if it would impact the school area at all. Mr. Dowd said that they would not impact the school. Mr. Nadrizny said that he had been working with them and all the costs would be covered by the University. Mr. Dowd repeated that the power line would be placed on park land and not near the school.

- 14. Peter Spain, 280 Grovers Avenue, Bridgeport, CT, requesting to turn off the 113 bluepole lights at St. Mary's by the Sea during the bird-mitigation season from August 15th November 15th.

Mr. Spain greeted the Commissioners and thanked everyone for their hard work. He said that there were 113 very bright white lights installed in St. Mary's by the Sea with no communal

input. He suggested that they turn off the lights during the mitigation season for an hour after dusk.

Mr. Nadrizny said that the lights were on photo sensors and would need to be rewired in order to turn them off. That would also require staff to manually turn them off. The lights were brighter when they were installed and since then shields have been installed. He said that they would have to do more research.

Mr. Spain asked if there was a way to use a timer where the power comes into the lights. Mr. Nadrizny said that they needed to do more research. The City electrician said that it would be very expensive to install timers since the lights were on photo sensitive timers. He added that he would like to speak with Chief Porter about safety issues.

Mr. Spain said that there was information in his letter that refutes the safety concerns. He pointed out that they were lighting a closed park from dusk to dawn and they could save some money on electricity. Commissioner Cotto said that there were no gates at St. Mary's by the Sea.

Commissioner Wade asked who would be responsible for the cost of rewiring the lights.

Mr. Spain said that there was regular street lighting all the way up to the last five houses along that stretch. The lamps are in the park. He said that the street has a 15 mile an hour speed limit, the street is actually in the park. Commissioner Hosier said that it was a City street. Mr. Spain said that he would forward a letter from the City Engineer about this to Commissioner Hosier. He added that the parking was by permit only which comes from the City.
