Atty. McLean greeted the Commissioners. This is the group's first time hosting the event at Seaside. Mr. Labrador said that usually they do not schedule any major events for Seaside on the 4th of July week-end. They reserve that week-end for the Bridgeport residents.

Ms. Conine, the Recreation Superintendent, said that it was the busiest week-end at Seaside and it is usually fully occupied. The parking attendants have to supervise the number of cars coming in and leaving to make sure there is parking available.

Mr. Caulfield, the Superintendent of Parks, said that it would not be fair to the event attendees or the residents since the park is so busy that week-end.

Commissioner Cotto said that all the years when he worked as a police officer on that week-end, it is very congested at the park. He was concerned about the safety and overcrowding.

Commissioner Wade agreed with Commissioner Cotto, Mr. Caulfield, and Ms. Conine.

Commissioner Taylor-Moye asked about the hours because they don't usually allow people to stay that late in park.

Commissioner Hosier asked Atty. McLean if he had an alternative date in mind. Atty. McLean said that they would be able to do it the week before or the week after. Ms. Urena checked the calendar and said that June 30th was still open.

Commissioner Labrador then reviewed the policies for the park usage. He explained that there are no lights in the park and that renting lighting is very expensive. Fencing will be required.

The Commissioners then reviewed the details of the diagram that Atty. McLean had submitted. The group does plan to serve alcohol.

Commissioner Labrador pointed out that they needed a second exit and that they would need to check people's wrist band to insure that the alcohol does not leave the bandshell area. Atty. McLean said that the attendees were over 25 years old. They will need to get permits if they are going to erect tents or staging,

Atty. McLean said that he would work on adjusting the dates and addressing the various concerns. Commissioner Labrador said that he wants the group to have a successful event. He cautioned Atty. McLean that the Police Department has asked them not to schedule too many big events too closely together because they can't provide coverage. He said that he was trying to be fair to everyone.

One of the members named Jimmy explained that they have a contract with the artist for the 4th of July week-end. Discussion followed.

Mr. Caulfield said that he was concerned about any damage to the course and restoring the area to its previous condition. Mr. Viera said that he would sign a hold harmless contract and that the slide film dissolves when it rains, so they will turn on the sprinklers.
