The first item was approval of the BAA Special Meeting Minutes held on February 21, 2021. Ms. Binkley made a motion to approve this Item. Ms. Martoral seconded the item. The motion carried unanimous 4-0.

The second Item was closing the 2021 BAA hearing sessions. The board reviewed 2 properties from a hearing that was completed at 9:40 a.m. and voted unanimous to deny both properties. Ms. Binkley motioned for the closing of the 2021 hearing sessions. Ms. Martoral seconded the item. The motion carried unanimous 4-0.
