12 Appeal – Mr. Thomas Hebert

The Commission has received a request for an appeal from Mr. Thomas Hebert regarding his termination from conditional employment as a Carpenter in the Board of Education.

Mr. Amado reviewed the details with the Commissioners. He asked Mr. Hebert if he wished to have the appeal heard in Public Session or Executive Session. Mr. Hebert stated his appeal could be heard in Public Session.

Mr. Amado said that Mr. Hebert was a probationary carpenter and gave a brief overview of the documents in the Commissioners' packet.

Mr. Hebert came forward and said he was a carpenter for 29 years with Carpenter's Local 326. There has never been any previous problems. His wife, who has cancer, made some brownies with cannabis and he unknowingly ate one.

Mr. Michael Robinson, a Carpenter's Local 326 representative, came forward and said that he had known Mr. Hebert for 14 years and there had never been an issue.

Mr. Robert Myer, a Carpenter's Local 326 building steward, came forward and said that he would never hesitate to recommend Mr. Hebert for a job.

Mr. Jose Pagan, a Carpenter's Local 326 Supervisor, came forward and said that he had known Mr. Hebert for a long time. Mr. Hebert was recommended by his union and was a good addition to the staff.

Discussion followed about the details of the issue. The BOE Public Facilities is in the random drug testing category.

Commissioner Grech pointed out that marijuana was being legalized in Connecticut and that there would be a number of cases like this.

There was also a comment made that a number of companies in New England and New York that were no longer testing for marijuana because it is legal now.

Commissioner Grech said that it was significant that the Supervisor came to the appeal hearing.

Mr. Amado said that the current policy would require termination during a probationary period. Mr. Hebert has been employed for three weeks.

Discussion followed about the difference between probationary employees and permanent employees along with possible solutions for the situation.

Brian Zayas – the request is to extend to August 17, 2022 Alex Scott – the request is to extend to August 17, 2022 Tyshawn Porchea – the request is to extend to September 14, 2022 William Vollenweider – the request is to extend for six months depending on medical status which will be evaluated sometime in November.

Acting Fire Chief Edwards came forward and gave an overview about the situation for the first four candidates. The first four candidates were accepted in 2020, and took the test once and failed to pass. During COVID, the test was revamped and made much more difficult.

-- Entry Level Fire Fighter – Some appeals have been received. They are being reviewed prior to submission to the Commission. Mr. Amado said that they were thinking about modifying the qualification sequence.

-- Tax Assessor – There will be a meeting with CPSHR about the job examination.
