- **8.** Appeal Jamel A. Small Tabled from August 8, 2022 and September 13, 2022 The Commission has received a request for an appeal from Jamal A. Small, regarding his disqualification from the selection process for entry level Firefighter #2380, due to not being recommended for hire based on the psychological evaluation.

Mr. Amado presented the item and noted that Mr. Small was present. Mr. Amado asked Mr. Small if he wished to have the hearing conducted in Executive Session or in Public Session. Mr. Small stated that he would prefer to have the hearing conducted in Public Session.

Mr. Amado said that the Commission had reviewed this item previously.

Commissioner Falberg asked Mr. Small if he had any questions for the Commissioners. Mr. Small said that he did not. The discussion moved to why the item was tabled.

\*\* THE APPEAL FROM JAMAL A. SMALL, REGARDING HIS DISQUALIFICATION FROM THE SELECTION PROCESS FOR ENTRY LEVEL FIREFIGHTER #2380, DUE

TO NOT BEING RECOMMENDED FOR HIRE BASED ON THE PSYCHOLOGICAL EVALUATION WAS UNANIMOUSLY APPROVED CONTINGENT UPON PASSING ANOTHER PSYCHOLOGIAL EVALUATION BECAUSE HIS EVALUATION WAS INCONCLUSIVE.

# 9. Appeal – Austin E. Boyle - Tabled from September 13, 2022

## 10. Appeal – Shakeem Fowler

The Commission has received a request for an appeal from Shakeem Fowler regarding his disqualification from the entry level firefighter exam #2380 regarding habits and conduct.

Mr. Amado presented the item and noted that Mr. Fowler was present. Mr. Amado asked Mr. Fowler if he wished to have the hearing conducted in Executive Session or in Public Session. Mr. Fowler stated that he would prefer to have the hearing conducted in Public Session.

Mr. Amado reviewed the details and noted that there were some documents in the information packet regarding his disqualification including the Internal Affairs investigation, a probation violation and motor vehicle record. Mr. Amado indicated his reasons for the disqualification.

Mr. Fowler came forward and said that the violation of probation was because he didn't successfully complete a task. He added that he had tried to get some legal representation but was not able to do so.

Mr. Amado said that the Commission could consider tabling the matter to the next meeting. Discussion followed.

- Exam Update
  - Police Officer Entry Level—Interviews completed off site. Scores are pending. Simultaneously, applications are being accepted for a second examination until October 30th.
  - Public Safety TCO Oral Exams are being set up.
  - Assistant Fire Chief Job analysis being created.
  - Fire Captain Announcement pending.

Discussion followed about the fact that the Police Sergeant promotional list has expired, which will be problematic when the promotions to Police Captain are announced.

Mr. Amado said that a number of exams were being given at one time because of the high number of turnovers. He explained that a "Certified Officer" designation was being considered. This would mirror lateral transfers, which the Charter Chapter 17 does not allow. The Commission will be presented with this proposed category in a few months. He outlined the details.

Mr. Amado announced that the next CSC meeting is scheduled for Monday, November 7, 2022 at 4:30 p.m. in the City Hall Wheeler Rooms.
