Aquaculture - Wesmac ADD \$56,160.00

Change Order came at the request of the school based on a trip taken in March 2021 to check on the status of the vessel. At the time this change order was requested, Wesmac requested an additional \$15,000 due to reinforcement for the crane. That change was immediately rejected as the reinforcement cost should have been factored in with the original request for the crane change. Mr. Flatto asked if the costs are reimbursable? Mr. Schilling replied, yes.

Change Order presented to have MJ Dalys controls contractor adjust the control sequence to tie in the dampers so when the system goes into "unoccupied mode" based on recommendations made by the Architectural firm, Silver Petrucelli, who designed the system. Mr. Garcia explained the chiller needs to be commissioned and not doing this is holding the project up from being commissioned and closed out.
