V. Bassick High School – Material Testing & Inspection Services

Material Testing and Inspections went out to bid on August 22, 2021. School Construction received six (6) responses varying from \$139,636 to \$514,107.

Recommendation was made to go with the lowest responsive, responsible bidder which was Test Con with a value of \$136,936.00

VI. Presentation from Nupower LLC

Mr. Donovan and Mr. Gilmartin were present to do a brief presentation on Nupower Thermal loop. Nupower proposed purchasing boilers which they will operate and maintain. Nupower will give \$480,000 to the purchase and installation of an absorption chiller. Nupower will provide a "Clean Energy" payment upon signing of \$30,000 as well as up to \$10,000 for any engineering cost associated with A/E costs to redesign.

Mr. Sokolovic expressed his concern that Nupower is coming to School Building Committee and must go before the Board of Education for approval or denial of a contract. Mr. Weldon replied that he and Mr. Sokolovic are on the School Building Committee to relay the information back to the Board of Education.

Mr. Gill questioned the timeframe as to when Nupower will be fully operational to provide heat. Mr. Donovan replied that the fuel cell will take 18 months to construct.

Mr. Testani expressed a concern to vet the possibility of the connection with the team of Architects and Engineers that are currently designing Bassick High School, Mr. Gill agreed.

Motion: Motion by Mr. Weldon to authorize the Bassick design team to explore with Nupower, the City Construction Team and BOE Building Operations

Discussion: Mr. Testani made the recommendation that Mr. Garcia, Mrs. Otero, Mr. Schilling and himself sit with the architect and engineer to see what the architect requires to make the connection with Nupowers thermal loop.

Aquaculture Floating Classroom - Project is moving along. Additional documentation was submitted for approval of crane installation.

Marin Elementary School – Currently closing out the project
