The Commission has received a request for an appeal from Michelle Farkas, regarding her disqualification from the Public Safety Telecommunicator exam #2387 hiring process due to not meeting the minimum qualification of typing speed.

Mr. Amado reported that the applicant was not present, and since there were prior requests to table, the appeal can no longer be continued.

#### 10. Appeal – Kenneth DuBose, Jr. Police Officer #2388

The Commission has received a request for an appeal from Kenneth DuBose, Jr. regarding his disqualification from the hiring process for the entry level Police Officer examination #2388, due to failing a portion of his medical examination.

Mr. Amado reported there was a request to table the appeal because there was a death in the family.

Mr. Amado asked the candidate if he wished to have the appeal heard in Executive or Public Session and explained the difference. Mr. Francis chose Executive Session.

## 12. Appeal – Bobbie Broadnax, Jr.

The Commission has received a request for an appeal from Bobbie Broadnax, Jr. regarding his disqualification from the hiring process for a seasonal position with the Fairchild Wheeler Golf Course due to failing a portion of his medical examination.

Mr. Amado asked the candidate if he wished to have the appeal heard in Executive or Public Session and explained the difference. Mr. Broadnax chose Executive Session.

\*\* COMMISSIONER FALBERG ASKED THE COMMISSIONERS TO VOTE ON THE APPEAL FROM BOBBIE BROADNAX, JR. REGARDING HIS DISQUALIFICATION FROM THE HIRING PROCESS FOR A SEASONAL POSITION WITH THE FAIRCHILD WHEELER GOLF COURSE DUE TO FAILING A PORTION OF HIS MEDICAL EXAMINATION.

COMMISSIONER GRECH VOTED TO GRANT THE APPEAL.

#### 13. Legal Opinion regarding Fire Lieutenant Examination #2384

Attorney John Mitola will discuss the legal opinion regarding Fire Lieutenant Examination #2384.

Atty. Mitola referred to the legal opinion as contained in the supporting document binder.

He summarized that the key issue is whether the Personnel Director violated the Bridgeport City Charter by allowing Firefighter Candidate to retake the promotional exam for Lieutenant within five days after the scheduled exam because the Candidate's wife went into labor on the day of the exam, and therefore was unable to take the exam. After research done on the details, it is the finding that the Personnel Director exercised his proper authority under the charter, and the law; and therefore, for reasons as outlined in the legal opinion, there is no violation of the charter.

Atty. Mitola reviewed details of the facts of the case and dates of the scheduled exam and the process whereby the Civil Service office retained IOS Solutions to develop the exam and work with the Civil Service to handle the process of scheduling and administering of the exam. He outlined the dates of the announcement (Exhibit A) of the computerized test procedures and email notifications, and charter mandated requirements. He added that (Exhibits B & Exhibit C) included requirements of reading list for preparation and included the process of a security deposit to ensure the candidates to show up for the exam. He added the confidentiality agreement (Exhibit E) that is intended to ensure no sharing of answers that would result in an unfair advantage of a make-up exam.

He reviewed details of notification by emails of the candidate's inability to take the exam, the Personnel Director's notice to IOS Solutions of the retake request, and the response by Consultant, Mr. Rob Shepard who evaluated the request and relayed information to Civil Service that a retake was it would not affect the integrity of the examination process and was within the guidelines, and he recommended the retake of the exam be done within five days.

He summarized that the purpose and purview of the Civil Service Office and legal opinion concluded that the Personnel Director followed procedures within his authority did not violate the Bridgeport City Charter (sections as outlined) by allowing Firefighter Candidate to retake the promotional exam for Lieutenant for the reasons as outlined.

# 14. Complaint and appeal regarding competitive promotional exam #2384 Fire Lieutenant (Tabled from January 9, 2024.

Personnel Director Amado read the item and asked the Commissioners if statement from the legal counsel would be heard. Chairperson Falberg replied that a summary would be heard and asked that the time be limited to five minutes.

Attorney Courtney George, representing the complainants in this matter and thanked the Commission for the opportunity to speak on this matter. She presented the statement for the appeal that the Personnel Director actions were justified on the purpose of Civil Service authority and purview, but the City Charter section 211 principles were violated by personally and privately granted the retake request without prior public notice violated CT state law.

She outlined that this is grounds for exception of competitiveness and created an unfair and unequal opportunity for the Candidate to retake the exam. She explained that the Opinion Letter got it wrong and read from the Charter on the purpose of Civil Service rules were violated by the Personnel Director for creating an unfair advantage for not following rules for hardship and retake procedures.

She emphasized that promotion tests could be held as necessary and notice and time and place and scope by public notice and takes the position that the test and subsequent make up test would require public notice, and she provided the rationale of the requirements of Civil Service.

Commissioner Ford asked if any of the complainants she represents requested to retake the exam. Atty. George replied, no.

Commissioner Grech asked Personnel Director Amado if he had any personal relationship to the candidate now or any time prior to the exam. Mr. Amado replied, no.

Chairperson Falberg asked if there was any situation in the past that established a precedent for retaking the exam. Mr. Amato outlined there were past situations of exam for alternative platforms for candidates to retake the exam for unforeseen circumstances, so this was not a rare occurrence.

Commissioner Grech asked to clarify the ruling of the appeal, and Attorney Mitola noted that granting would result in taking the candidate off of the list; and for a denial, he would remain on the list.

\*\* COMMISSIONER FALBERG ASKED THE COMMISSIONERS TO VOTE ON THE COMPLAINT AND APPEAL REGARDING COMPETITIVE PROMOTIONAL EXAM #2384 FIRE LIEUTENANT (TABLED FROM JANUARY 9, 2024).

COMMISSIONER GRECH VOTED TO DENY THE COMPLAINT AND APPEAL. COMMISSIONER FORD VOTED TO DENY THE COMPLAINT AND APPEAL. COMMISSIONER RODGERS VOTED TO DENY THE COMPLAINT AND APPEAL. COMMISSIONER HALL VOTED TO DENY THE COMPLAINT AND APPEAL.

\*\* THE COMPLAINT AND APPEAL REGARDING COMPETITIVE PROMOTIONAL EXAM #2384 FIRE LIEUTENANT WAS UNANIMOUSLY DENIED.
