EXAMINATION ANNOUNCEMENT

The Civil Service Commission of the City of Bridgeport will conduct a competitive promotional examination for **Senior Fire Inspector**. The exact date, time and location of the examination will be announced at a later date to all qualified candidates.

SALARY RANGE: \$105,341 - \$109,453 - \$113,586; appointments to be made at the minimum or entrance salary of \$105,341 per year. Advancements within the salary range may be made in accordance with the terms of the contract between the City of Bridgeport and Bridgeport Fire Fighters Local 834, AFL-CIO.

APPLICATIONS: Each candidate must complete an [online application form](#) supplied by the Commission and file it no later than 11:59 p.m. on **Sunday, March 8, 2026**. Each candidate must submit a refundable security deposit of \$150 in the form of a payroll deduction authorization form as part of the application process. This security deposit will be deducted for any applicant who does not appear for all parts of the examination at the proper date and time. *

GENERAL STATEMENT OF DUTIES:** The Fire Inspector performs duties as outlined by the Fire Marshal or Deputy Marshal, including fire investigations and facility inspections. The Inspector will also act in an advisory role at fire scenes. The Inspector regularly inspects buildings and locations within the Fire District for Fire Safety, access, hazards, etc., investigates the cause, origin, and circumstances of all fires within their jurisdiction, reads and prepares reports, performs supervisory and office related duties. This worker will also attend meetings, continuing education classes and present information to the general public on fire safety issues.

REQUIREMENTS: This examination is open to members of the Bridgeport Fire Department who have **three years' experience prior to October 15, 2023**. ***

All persons appointed to the position of Fire Inspector must be certified by the State of Connecticut. All persons appointed will be allowed only one attempt to achieve certification during the probationary period. All persons appointed must comply with all state requirements in order to maintain state certification.

* To ensure that candidates who apply will present themselves for the competitive promotional examination, the Civil Service Commission requires that all applicants provide the Office of the Civil Service Commission with a security deposit to hold a place for the candidate at the examination. Candidates who apply for examination but do not appear at the proper date, time and place will forfeit their deposit at the discretion of the Personnel Director. A detailed explanation for this security deposit can be obtained by requesting a copy from the Civil Service office.

** This is a current general statement of duties for the purposes of this announcement and is subject to change based on a job analysis that is presently being conducted by the Office of the Civil Service Commission. The official job description is expected to be modernized and updated accordingly.

*** The first true vacancy per Walker v. Jankura ruling and Chapter 17, Section 211 (b) of the 1994 Charter of the City of Bridgeport, was Leonard Bonaventura's retirement on 06/16/2023.

SUBJECTS OF EXAMINATION: The promotional process for the position of Senior Fire Inspector in the Bridgeport Fire Department will be an assessment center style process which may include role playing exercises, in-basket exercises, oral board questions, or other assessment center style exercises****, weighted at 95%; Seniority weighted at 5%. Candidates will be required to pass a qualifying service rating in order to be placed on the employment list.

PASS POINT: The passing point will be set at that score which is 70% of the highest score made (e.g., if highest score = 90, the passing score = 63%).

SPECIAL ACCOMMODATION: The Civil Service Commission will provide reasonable accommodation for persons with a disability to take a test. To request special accommodation, please submit, in writing, a statement of what type of accommodation is being requested. You will be required to provide proof of any disability requiring accommodation. This request must be received by the Office of the Civil Service Commission at least 14 days prior to the examination date.

EXAMINATION REVIEW PROCEDURES: Each candidate will have an opportunity to review his or her examination during the one-month period after the date of announced results. The papers will be open to inspection during the hours of 9:00 A.M. to 1:00 P.M. Monday through Friday, excluding holidays. Every inspection period will be monitored by the staff of the Civil Service Office, and no candidate will be allowed to copy examination questions or to take any written material from the review room.
